

## 22. ANNEX 2 TO THE REGULATIONS - DIET BY MAGDA GESSLER

1. This annex to the Regulations determines the specific terms and conditions for the purchase and completion of the Diet by Magda Gessler. In the scope not covered by this Annex, the Regulations shall apply.
2. The Diet by Magda Gessler is one of the Diets available on the Body Chief Website and it cannot be purchased via the Body Chief Application.
3. Specific terms and conditions for using the Order Form, placing an Order and concluding a contract for the provision of the Service in the case of the Diet by Magda Gessler are the following:
  - a. The Customer independently composes his or her diet as part of the Diet By Magda Gessler from 30 offered dishes available in the Order Form.
  - b. First, the Customer selects the duration of the Diet By Magda Gessler (from 1 to 7 days). Then the Client can compose the diet. The Customer chooses each type of meal (1st breakfast, 2nd breakfast, lunch, afternoon snack, supper) from 6 available meal options, and then from 4 types of calorific value. The Customer can choose 5 meals for each day of the Diet. The Client can check the ingredients of each dish on our website.
  - c. After selecting all meals for a given day, the Client sees the price of the Diet for one day.
  - d. The Customer may use the "duplicate days" option in the Order Form, i.e. after selecting all meals and the duration of the Diet longer than one day, he or she may copy them to other days. Moreover, it is possible to compose meals for the remaining days differently, taking into account the rules mentioned above.
  - e. The Diet By Magda Gessler is available in limited quantities. After placing the Order, the Seller immediately confirms its receipt and, if the Diet is available in the period selected by the Customer, accepts it for completion, which is unambiguous to concluding a contract for the provision of the Service. If the Diet by Magda Gessler is unavailable in the period selected by the Customer, the Seller shall immediately inform the Customer about it and enables him or her to change the duration of the Diet by Magda Gessler to the nearest available and accepted by the Customer period or accept the Customer's resignation from the Diet completion. The very beginning of the Service completion depends on the Service commencement date, indicated in the accepted Order, and on the prior payment of the Customer in accordance with the conditions specified in the Regulations.
  - f. After placing the Order, the Customer will receive a summary, which will include a detailed specification of what meals were selected for a given day, what calorific value they have and what is the price of the daily order. The summary will be an additional PDF attachment, which the Customer will receive in the e-mail confirming the Order placement.
  - g. The Diet by Magda Gessler completion (deliveries) begins from the Service commencement date, indicated in the accepted Order, taking into account the following rules:
    - i. if the Seller's bank account or settlement account is credited with the Customer's payment for the Service by 2 p.m. on days from Monday to Thursday, the Service will begin on the second day following the order payment (for instance: the Service paid on Monday at 10:00 a.m., may be delivered on Wednesday at the earliest), but not earlier than on the day of the Service commencement indicated in the accepted Order;
    - ii. if the Seller's bank account or settlement account is credited with the Customer's payment for the Service by 2 p.m. on Friday, the Service will not begin until the next Monday at the earliest. The Service commencement date will be each time indicated in the accepted Order;
    - iii. if the Seller's bank account or settlement account is credited with the Customer's payment for the Service by 2 p.m. and after that time on Saturday, the Service will not begin until the next Tuesday at the earliest. The Service commencement date will be each time indicated in the accepted Order;

- iv. if the Seller's bank account or settlement account is credited with the Customer's payment for the Service on Sunday, the Service will not begin until the next Tuesday at the earliest. The Service commencement date will be each time indicated in the accepted Order;
  - v. if the Seller's bank account or settlement account is credited with the Customer's payment for the Service after 2 p.m. on Monday to Friday and on Sunday, the Service will begin in accordance with the rules applicable until 2 p.m. on the following day. The Service commencement date will be each time indicated in the accepted Order.
- h. In the remaining scope, the Regulations shall apply.
- 4. Specific terms and conditions regarding the methods and terms of Service payment in the case of the Diet by Magda Gessler:
  - a. The Customer is obliged to make the payment for the Diet by Magda Gessler at the latest by 2:00 p.m., 2 working days before the Service commencement date indicated in the accepted Order.
  - b. In the remaining scope, the Regulations shall apply.
- 5. Specific terms and conditions regarding costs, methods and dates of Service delivery in the case of the Diet by Magda Gessler:
  - a. The delivery of the Diet by Magda Gessler is available only in the Delivery Area, referred to in section 11 paragraph 2 of the Regulations.
  - b. In the remaining scope, the Regulations shall apply.
- 6. Specific terms and conditions regarding the contractual withdrawal from the contract for the Service provision, referred to in section 14 of the Regulations, in the case of the Diet by Magda Gessler:
  - a. The Customer has the right to withdraw from the Diet by Magda Gessler agreement without giving any reason by 2:00 p.m. 2 working days before the Service commencement date indicated in the accepted Order.
  - b. The Customer has the right to modify the contract for the provision of the Diet by Magda Gessler without giving any reason by 2:00 p.m. 2 working days before the Service commencement date indicated in the accepted Order. The changes referred to in the preceding sentence may concern: (1) the change of the delivery address or delivery time; (2) meal changes; or (3) changes of calorific value. If the change of the meal or of the calorific value includes a change from a cheaper option to a more expensive one, the Customer is obliged to pay the difference. The Seller will inform the Customer about the difference in the price.
  - c. In the remaining scope, the Regulations shall apply.
